INSTRUCTIONS FOR NOMINATING OFFICERS AND DIRECTORS

1. Only regular members of the Young Lawyers Section (the "Section") who are in good standing and who will not have reached their 36th birthday by July 1, 2026, may be nominated for office or directorship. No member may be nominated for the office of President-Elect unless that member shall first have served for at least one year either as Secretary, Treasurer, or Director of the Section. No member who has previously served as President of the Section may be nominated for that office. No member who has previously served as Secretary or Treasurer of the Section for two (2) regularly elected terms may be nominated for such office or offices. Any Section member may be nominated for an "At-Large" seat, but only Section members who will be under the age of 30 subsequent to July 1, 2026, and who have never been an Officer or Director of this Section may be nominated for an "Under-Age 30" seat.

2. The signatures of five regular members of the Miami-Dade Bar, in good standing, are required to nominate. All members entitled to nominate and vote in the election have been e-mailed a copy of the Nominating Ballot and any questions as to eligibility should be verified through the Executive Office of the Miami-Dade Bar. The required nominating signatures may be contained in one nominating ballot or may be submitted on separate ballots. You may nominate for any or all offices and directorships indicated below. E-signatures are accepted, please provide authorization email from nominator.

3. The person elected as President-Elect, by Article IV (2b) of the Section's By-Laws automatically becomes the President for the 2027-2028 term. Directors serve two (2) year terms. Officers serve one (1) year terms.

4. All Officers and Directors are invited to attend the Installation Gala on Friday, May 29, 2026.

5. **All nominating ballots must be received by the Elections Chairperson at the Executive Office of the Miami Dade Bar, 150 W. Flagler Street, Suite 1675, Miami, FL 33130, or by email to bret@miamidadebar.org prior to 5:00 p.m. EDT on April 2, 2026. (NO EXCEPTIONS).**
