



2026 MIAMI DADE BAR ASSOCIATION ELECTIONS
NOMINATING BALLOT AND INSTRUCTIONS

- 1. The Membership Roster contains the names of Regular Members (Government Members and Judicial Members are considered Regular Members) and Life Members of the Miami Dade Bar ("MDB").
- 2. Regular Members and Life Members are eligible to nominate and vote. Regular Members and Life Members who maintain their primary offices for the practice of law in Miami-Dade County as indicated by their designated Florida Bar address may hold office as Officers or Directors. Regular Members and Life Members in good standing who have served at least two full years' service on the Board of Directors within the last three years are eligible to run for an Officer position. Members of the judiciary may not run for Office. Associate Members may not nominate, vote, or hold office.
- 3. The person elected President-Elect in this election will automatically be President for the 2027-2028 fiscal year.
- 4. The current President-Elect may not be nominated for any office, but the current President and any other OFFICER may be nominated for any Officer or Director vacancy.
- 5. Terms are One year for Officers and Three years for Directors. All terms begin July 1, 2026.

SPECIFIC INSTRUCTIONS

- 1. Review the Membership Roster to determine the proper group for Director nomination.
- 2. Type or print name(s) of candidate(s) for Officer or Director vacancy. INCLUDE Florida Bar number. A single ballot may be used for one or several nominations or several ballots may be used for each candidate - so long as a total of six (6) Regular or Life Members nominate.
- 3. Have six (6) Regular or Life Members sign the nominating ballot. (Please double check the Membership Roster, available on the MDB website, to make certain your nominators are MDB members).
- 4. TYPE or print the names of nominators beneath their signatures. E-signatures are accepted, please provide authorization email from nominator. Multiple forms may be used and submitted, if needed.
- 5. Return the Nominating Ballot to MDB by 5 p.m. EDT, April 2, 2026.
